**Santiago, Chile. March 11, 2015.-** Sociedad Química y Minera de Chile S.A. (SQM) (NYSE: SQM; Santiago Stock Exchange: SQM-B, SQM-A) today issued a press release in Spanish, a convenience translation of which follows:

SQM informs that it has not presented any request to avoid delivery of information to the Public Prosecutor (*Ministerio Público*). The Board of Directors of SQM will meet tomorrow to evaluate the request by the Public Prosecutor for delivery of information. The Public Prosecutor was timely informed by SQM that it is analyzing the legal appropriateness of such request.

The statement above relates to a request made to SQM for delivery by SQM of accounting records and related information in connection with the Public Prosecutor's investigation into improper political campaign contributions.
