

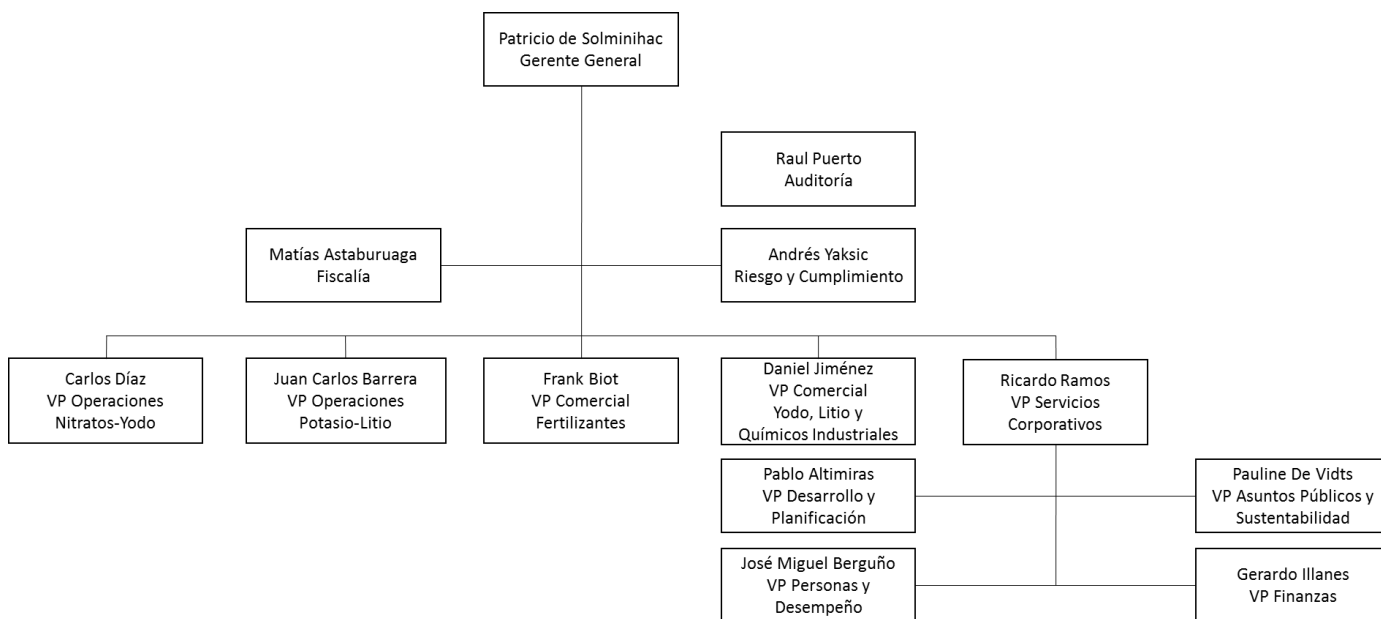


Para distribución inmediata SQM ANUNCIA CAMBIO EN ESTRUCTURA ORGANIZACIONAL

Santiago, Chile. 18 de Mayo de 2016.- Sociedad Química y Minera de Chile S.A. (SQM) (NYSE: SQM; Santiago Stock Exchange: SQM-B, SQM-A) anuncia reestructuración organizacional, como parte del desarrollo estratégico de la Compañía. La nueva estructura contempla vicepresidencias comerciales distintas para el negocio de fertilizantes y para el negocio industrial, para enfrentar las características particulares de cada segmento. Adicionalmente, se han creado vicepresidencias responsables de las áreas de desarrollo y planificación, personas y desempeño, asuntos públicos y sustentabilidad, y finanzas, todas reportando a un vicepresidente de servicios corporativos.

Al respecto, el Gerente General de SQM, Patricio de Solminihac, dijo: “Hemos trabajado arduamente en los últimos meses para evaluar la mejor manera de enfrentar los desafíos que vemos en los distintos mercados en los que participamos en los próximos años. Consecuentemente, hemos decidido hacer cambios organizacionales que nos permitan enfocar nuestros esfuerzos en las prioridades de nuestro negocio de manera más efectiva. Los ejecutivos que han sido nombrados a cargo de cada una de las vicepresidencias tienen una trayectoria exitosa con la Compañía. Estoy convencido en que SQM cuenta con un gran equipo humano que podrá sacar adelante los desafíos que se nos presentarán en el futuro, creando valor para nuestros accionistas, clientes, colaboradores y comunidades donde interactuamos”.
