



Conditions in the North of Chile

Santiago, Chile, March 26, 2015 – Sociedad Química y Minera de Chile S.A. (SQM) (NYSE: SQM; Santiago Stock Exchange: SQM-A, SQM-B), informed that due to the rain and flooding that began yesterday in the north of Chile, SQM's operations were halted as a preventative measure, although there have been no injuries to people or damage to facilities. The facilities involved are María Elena, the port of Tocopilla, Coya Sur, Pedro de Valdivia and the Salar de Atacama. Our operations at Nueva Victoria, located in the Tarapacá region, are operating normally.

Road conditions have made it difficult to transport our workers to and from the mine sites. The Company is taking care of workers' needs at the facilities while we wait for conditions to improve, so that normal transportation can resume.

The Company is also helping its workers in the city of Antofagasta who have been affected by the storm. Administrative offices were closed for electrical repairs on Thursday.
