Highlights

- Decrease in land cost mainly due to ASC 842 lease accounting entries. Land cost excl. ASC 842 was 17.8% in Q2 '26 compared to 17.3% in Q2 '25.
- Excluding the ASC 842 impact on land cost mentioned above, adjusted EBITDA organically grew 2.3% YTD YoY.
