## HUMAN RIGHTS POLICY

### PURPOSE

We resolve to act reasonably to minimize and, where possible, eliminate, any negative impact our activities have on human rights or the communities where we do business. Respect for human rights is a fundamental part of our global sustainability strategy.

### GUIDING PRINCIPLES

Murphy is further committed to a complete prohibition against child labor as well as recognizing that access to water is also a fundamental human right. Beyond these fundamental human rights, Murphy actively conducts programs regarding specific issues and groups; including diversity, equity and inclusion programs that recognize the benefit of the meaningful presence and participation of women and minorities in our business as well as our industry.

Murphy continuously strives to build and implement policies that support and recognize the importance of human rights. Murphy's commitment to human rights is not only a reflection of our core values and heritage, but a policy mandated by our Board of Directors. Murphy is committed to investigating good faith concerns thoroughly and providing appropriate responses and remedies.

Murphy continues its longstanding practice of engaging with local stakeholders regarding our presence and ability to positively impact communities in which we do business. We will ensure that this engagement furthers the goals set forth in this policy.
